


The Guild is being presented an




You will receive a proposal in writing

20,000 table saws recalled



This article was released in December 2004 but is still relevant today. If you have, or know of someone who has this saw, please pay attention to this article.

Robert Bosch Tool Corporation, of Mount Prospect, Ill. is recalling 120,000 Skil® Model 3400 Table Saws

The blade drive mechanism may loosen or the motor can separate from the tool.

Loosening of the blade drive mechanism can result in kickback of the item being sawed, resulting in possible laceration. Motor unit separation can cause the coasting saw blade to damage the saw wiring resulting in possible electric shock, or the separated motor could strike the user and cause injury.

> Robert Bosch Tool Corporation has received eleven reports of loose or broken motors. No injury or property damage has been reported.

> Only Skil® table saws with model number 3400 printed on the front side of the table base with the date codes listed below are included in the recall.

Date codes are printed on the upper right corner of the table base and include 2002 date codes 28501-28831, 2003 codes 38101-39231 and 2004 codes 48101-48811. The table saw holds a 10inch blade and is made of metal tabletop with a red plastic base.

Home Depot, Lowe's, and Menards, as well as independent hardware retailers nationwide, sold the equipment from July 2002 through October 2004 for between \$149 and \$199.

If you have one of these saws, contact Robert Bosch Tool Corporation to receive a repair kit. The kit includes hardware and instructions for installation.

Outrigger Resorts Feature Craftsmen Programs

Woodworkers and quilters can combine a summer vacation to Hawaii with



an opportunity to learn about Hawaiian furnituremaking and Hawaiian quilting from some of the islands' foremost masters.

The Outrigger Waikiki on the Beach and the Outrigger Reef on the Beach are hosting a series of homeoriented events from May through August, 2005, as part of their ongoing series of Hawaiian cultural and educational guest programs.

Most of these events are free and open to the public. "Defining Home: Native Woods, Western Objects" focuses on Hawaiian furniture-making, and is a collaboration between the Outrigger properties and the Mission Houses Museum on Oahu. From May 20 through August 20, 2005, a unique collection of Hawaiian furniture and furnishings will be on display at the Mission Houses Museum in downtown Honolulu.

The special exhibit tells the story of furniture-making in Hawaii and explores the use of native Hawaiian woods, cross-cultural influences, unique island adaptations, and the evolution of this distinctive craft over time. In conjunction with the "Defining Home" display, the Outrigger Waikiki on the Beach will be hosting a series of free presentations by James Ferla, one of the state's most notable experts on fine woodworking and Hawaiian furniture-making.

Originally from Connecticut, Ferla began experimenting with wood at the age of 9, and in his career has restored or built hundreds of antiques and heirloom pieces for private owners across the country. Ferla's presentations will take place at the Outrigger Waikiki on the Beach on June 4, July 9 and August 6, 2005, from 11 a.m. to 12 noon.

The presentations are free and open to the public. Hawaiian quilting takes the spotlight at both the Outrigger Waikiki on the Beach and the Outrigger Reef on the Beach in June. From June 10 to 12,

> 2005, the Outrigger Waikiki on the Beach will display exquisite handmade quilts honoring Hawaiian monarchs Kamehameha I, King David Kalakaua, Queen Kaahumanu and Queen Liliuokalani; as well as one of the oldest quilts of the Hawaiian flag.

Guests staying at the property can receive a complimentary kalo (taro) quilt pattern that was specially designed for the hotel. The display is free and open to the public. On June 10 and 11, 2005, the Outrigger Reef on the Beach hosts a free exhibition of more than 30 hand-made Hawaiian quilts. In addition, quilters can attend a two-day Hawaiian Quilt Design Workshop led by designer John Serrao of Poakalani Hawaiian Quilt Designs.

Serrao has authored four books and taught numerous classes on Hawaiian quilting, and his company has created more than a thousand quilt designs. The Hawaiian Quilt Design Workshop will take place from 9:30 a.m. to 3:30 p.m., June 10 & 11, 2005, at the Outrigger Reef on the Beach. Registration fee is \$105 per person, and each participant staying at the Outrigger Reef on the Beach will receive a complimentary quilt book.

What is your specialty in woodworking? I don't think I have a specialty. Re-

cently, I have been making furniture as well as a few toys for the grandkids.

How many years have you been woodworking?

22 years ago, my wife and I tried to buy some additional pieces of furniture to match some of our existing pieces. The line was no longer available, so I thought about making at least one of the items we wanted. My daughter said that it would not be the same. I took that as a challenge. She could not identify the copy when it was finished. Soon after I built kitchen cabinets for our new house, Then I went on a long quiet spell. With my retirement three years ago I have renewed my interest and activity in woodworking.

What is your favorite hand tool and why?

I had think about this one, but one tool I use on every project is sandpaper. With sandpaper we give or contribute to the wood's the final feel and finish. We use it to take off rough edges and remove minor defects. I also use scrapers and Spoke shaves to do the same but to a limited degree.

What is your favorite power tool and why?

Perhaps the router, as I make more fixtures and jigs and acquire more bits; the versatility of the router continues to expand.

What is your favorite wood to use and why? Cherry has been my favorite lately. I like the feel of hand rubbed cherry and the color gets better with age.

What is your most favorite project you have built and whv?

I am working on a cherry bedroom set. It started with a queen size bed, which I built from a photograph. Two bedside tables, of my own design, are nearing completion. And I am working on the design for a chest of drawers.

What is the best deal you have gotten on a woodworking tool?

A friend and fellow woodworker of mine works predominately on a lathe. He had not used a new 6" jointer he had purchased a few years ago and wanted the space in his shop back. He ask \$50, I gave him \$75.

From my father-in-law always said to "Measure twice, cut once!". For me this is particularly important as I create some of my own designs, modify most others and often changing dimensions during one phase or another of the project.
